Article I

Allocation of financial support from the Erasmus+ program – Project No. 2018-1-HR01-KA107-047120, is approved to the following students:

Article II

Applicants – students, listed in the Article I of this Decision, shall be granted financial support in Euros according to the rules and regulations of the Erasmus+ project 2018-1-HR01-KA107-047120. The mobility shall be realized at the Faculty of Economics at the Josip Juraj Strossmayer University of Osijek, in the summer semester of the academic year 2019/2020. Financial support will be granted in the monthly amount of 800,00 EUR for study, and additional travel costs in the amount of 360,00 EUR. Financial support shall be paid out in Croatian Kuna.

Article III

The applicants listed in the Article I of this Decision shall use financial support for the purpose of studying at the Faculty of Economics at the Josip Juraj Strossmayer University of Osijek and for payment of all living costs while staying in Osijek.

Article IV

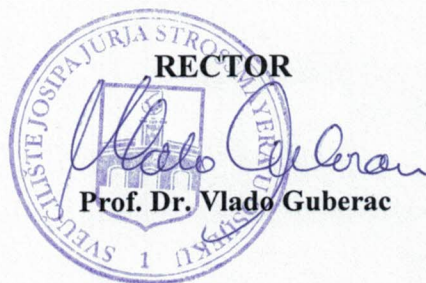
