DECISION

on granting financial support from the Erasmus+ program to incoming students for the individual study stay at University of Osijek in the summer semester of the academic year 2021/2022

Article I

Allocation of financial support from the Erasmus+ program – Project No. 2019-1-HR01-KA107-060762 is approved to the following students:

Article II

Article III

The applicant listed in the Article I of this Decision shall use financial support for the purpose of studying at the University of Osijek and for payment of all living costs while staying at their mobility.

Article IV

The mutual rights and obligations, as well as final amount of the financial support, which each applicant is entitled to receive, shall be defined in a separate Erasmus+ agreement that will be closed between Josip Juraj Strossmayer University of Osijek and individual applicant, as listed in the Article 1 of this Decision.

Article V

This Decision shall enter into force as of the date of signing.
