DECISION

on granting financial support from the Erasmus+ program to incoming (non)teaching staff for training and teaching within individual visit to University of Slavonski Brod, University of Sarajevo and Yerevan State University

Article I

Allocation of financial support from the Erasmus+ program – Project No. 2019-1-HR01-KA107-060762, is approved to the following (non)teaching staff members:

Article II

Applicants listed in the Article I of this Decision, shall be granted financial support in Euros according to the rules and regulations of the Erasmus+ project 2019-1-HR01-KA107-060762. The mobility for the purpose of training and teaching shall be realized at the Faculty of Mechanical Engineering in Slavonski Brod (Begić Hajdarević, Čekić, Čohodar Husić). The mobility for the purpose of teaching shall be realized at Yerevan State University (Karnaš,

Rastija). The mobility for the purpose of teaching shall be realized at University of Sarajevo (Stojšić). Financial support will be granted as follows:

1. **Stojšić, Josip** – 1.260,00 EUR for per diems and 180,00 EUR for travel.
2. **Begić Hajdarević, Đerzija** – 980,00 EUR for per diems and 180,00 EUR for travel.
3. **Čekić, Ahmet** - 980,00 EUR for per diems and 180,00 EUR for travel.
4. **Čohodar Husić, Maida** - 980,00 EUR for per diems and 180,00 EUR for travel.
5. **Karnaš, Maja** - 1.620,00 EUR for per diems and 360,00 EUR for travel.
6. **Rastija, Vesna** - 1.620,00 EUR for per diems and 360,00 EUR for travel.

Financial support shall be paid out in Croatian Kuna.

Article III

The applicants listed in the Article I of this Decision shall use financial support for the purpose of teaching and training at the realized Faculty of Mechanical Engineering in Slavonski Brod (Begić Hajdarević, Čekić, Čohodar Husić), at Yerevan State University (Karnaš, Rastija) and at University of Sarajevo (Stojšić) for payment of all living costs while staying at their mobility.

Article IV

The mutual rights and obligations, as well as final amount of the financial support, which the applicants are entitled to receive, shall be defined in a separate Erasmus+ agreement that will be closed between Josip Juraj Strossmayer University of Osijek and the applicants, as listed in the Article 1 of this Decision.

Article V

This Decision shall enter into force as of the date of signing.

Article VI

Applicants listed in Article I may file a written complaint against this Decision within 8 working days since receiving this Decision.
