Pursuant to the Article 43 of the Statute of Josip Juraj Strossmayer University of Osijek and based on the proposal of the Committee for the Erasmus+ mobility program, the Rector of Josip Juraj Strossmayer University of Osijek, Prof. Dr. Vlado Guberac makes the following

DECISION

on granting financial support from the Erasmus+ program to incoming students for the individual study at Josip Juraj Strossmayer University of Osijek in the summer semester of the academic year 2021/2022

Article I

Allocation of financial support from the Erasmus+ program – Project No. 2019-1-HR01-KA107-060762, is approved to the following students:

- KASYMOVA, Asel, student of the Ala-Too International University in Bishkek, Kyrgyz Republic
- 2. **SHAIDULLAEVA**, **Aizhamal**, student of the Ala-Too International University in Bishkek, Kyrgyz Republic

Article II

Each Applicant – student, as listed in the Article I of this Decision, shall be granted financial support in Euros according to the rules and regulations of the Erasmus+ project 2019-1-HR01-KA107-060762. The mobilities of both Applicants - students shall be realized at the Faculty of Education of Josip Juraj Strossmayer University of Osijek, in Osijek, Republic of Croatia, in the summer semester of the academic year 2021/2022, i.e. from 01 March 2022 until 31 July 2022. Financial support will be granted in the monthly amount of 800,00 EUR for study (i.e. in the maximum amount of 4,000.00 EUR for a total duration of stay), and additional travel costs in the amount of 820,00 EUR. Financial support shall be paid out in Croatian Kuna upon students' arrival in Osijek and registration at the Faculty of Education of Josip Juraj Strossmayer University of Osijek.

Article III

The Applicants - students listed in the Article I of this Decision shall use financial support for the purpose of studying at the respective Faculty of Education of Josip Juraj Strossmayer University of Osijek, and for payment of all travel costs, visa and insurance costs, as well as all accommodation and living costs while staying in Osijek.

Article IV

The mutual rights and obligations, as well as final amount of the financial support, which each Applicant is entitled to receive, shall be defined in a separate Erasmus+ agreement that will be closed between Josip Juraj Strossmayer University of Osijek and individual Applicant-student, as listed in the Article 1 of this Decision.

Article V

This Decision shall enter into force as of the date of signing.

Article VI

The Applicants-students listed in Article I may file a written complaint against this Decision within 8 working days since receiving this Decision.
