Pursuant to Article 43 of the Statute of Josip Juraj Strossmayer University of Osijek and based on the proposal of the Committee for Erasmus+ mobility program, the Rector of Josip Juraj Strossmayer University of Osijek, Prof. Dr. Vlado Guberac makes the following

DECISION

on granting financial support from the Erasmus+ program to incoming and outgoing (non)teaching staff for training and teaching within individual visit to University of Osijek and University of Montenegro

Article I

Allocation of financial support from the Erasmus+ program – Project No. 2019-1-HR01-KA107-060762, is approved to the following (non)teaching staff members:

1. **Berbić Kolar, Emina**, employee of the University of Osijek, Croatia
2. **Akylbek Uulu, Nazarbek**, employee of the Ala-Too International University, Kyrgyzstan
3. **Irenchieva, Gulnura**, employee of the Ala-Too International University, Kyrgyzstan
4. **Musuralieva, Gulnara**, employee of the Ala-Too International University, Kyrgyzstan

Article II

Applicants listed in the Article I of this Decision, shall be granted financial support in Euros according to the rules and regulations of the Erasmus+ project 2019-1-HR01-KA107-060762. The mobility for the purpose of teaching shall be realized at the University of Montenegro (Emina Berbić Kolar). The mobility for the purpose of training shall be realized at the University of Osijek (Akylbek Uulu, Irenchieva, Musuralieva). Financial support will be granted as follows:

1. **Berbić Kolar, Emina** – 1.260,00 EUR for per diems and 180,00 EUR for travel.
2. **Akylbek Uulu, Nazarbek** – 1.960,00 EUR for per diems and 820,00 EUR for travel.
3. **Irenchieva, Gulnura** - 1.960,00 EUR for per diems and 820,00 EUR for travel.
4. **Musuralieva, Gulnara** - 1.960,00 EUR for per diems and 820,00 EUR for travel.

Financial support shall be paid out in Croatian Kuna.

Article III

The applicants listed in the Article I of this Decision shall use financial support for the purpose of teaching at the University of Montenegro (Emina Berbić Kolar) and training at the Faculty of Education of the Josip Juraj Strossmayer University of Osijek (Akylbek Uulu, Irenchieva, Musuralieva) for payment of all living costs while staying at their mobility.

Article IV

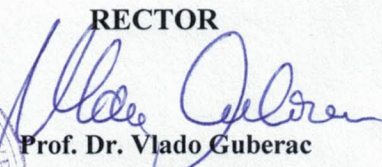
The mutual rights and obligations, as well as final amount of the financial support, which the applicants are entitled to receive, shall be defined in a separate Erasmus+ agreement that will be closed between Josip Juraj Strossmayer University of Osijek and the applicants, as listed in the Article 1 of this Decision.
