Josip Juraj Strossmayer University of Osijek (UNIOS) was established in 1975. Today it has 18731 students and 1458 members of academic staff. UNIOS main strategic objectives are development and assurance of high quality research and teaching, internationalization and promotion of student and staff mobility, promotion of international ties with partner institutions, involvement in European trends (ERA, EHEA), contribution to social, cultural and economic life of the region and further infrastructure development. UNIOS assures academic atmosphere that welcomes students, teachers and staff irrelevant of their national origin, gender, religion, ethnic background, sexual orientation or physical disability. Non-discriminatory policy is incorporated in the University Statute and pursued in everyday university life. Any behavior in favor of xenophobia and racism is strictly forbidden and punished, as foreseen in the University Ethical Codex. Students are enrolled by faculties on the basis of entrance exams, students of low-income groups are given priority in the selection procedure by student dormitories, teachers are given equal opportunities for academic advancement on the basis of set criteria, physically disabled students and staff are provided access to university facilities (elevators and ramps are provided at most of the faculties). UNIOS offers studies in all scientific fields. Since the academic year 2005/2006 it carries out studies fully revised according to the Bologna principles. There are 31 university undergraduate studies, 35 university graduate studies, 3 one-tier studies, 23 postgraduate professional studies within lifelong learning program and 11 doctoral studies. International cooperation with institutions abroad is related to organization of joint curricula, exchange of students and teachers, joint symposia, seminars, exchange of information on scientific and research activities. There is cooperation at bilateral level with universities in 16 European countries, in Turkey and Russia. Participation in Erasmus is seen as a main tool to promote student and academic mobility and to strengthen European ties towards inclusion in EHEA. In the framework of multilateral cooperation, UNIOS participates in the activities of the Alps-Adriatic Rectors' Conference directed towards intensification of cross-border co-operation, organization of joint study programs and promotion of lifelong learning. UNIOS is member of the Danube Rectors' Conference, and Cross-Border Cooperation initiative that connects universities, cities and counties in the cross border area of Croatia and Hungary. UNIOS joined the CEEPUS network, attracting students from Central and Eastern Europe and enabling home students to study abroad. From 2001-2008 UNIOS participated in 26 TEMPUS projects. Through different measures UNIOS aims to accelerate involvement of researchers in the 7th Framework program as it sees this Program as a tool to assure high quality research and the only way to become a part of ERA. Our researchers have already participated in several FP projects, however more intensive participation is stimulated through assistance offered by the University Research Office and the Research Committee. For the purpose of promoting Erasmus activities, UNIOS has established a web site on which all relevant information, strategic documents, Erasmus Policy Statement and EUC will be published. EPS and EUC will be also presented at Senate session and sent to faculties to be published on their web pages. Students and staff will be informed on calls and possibilities for Erasmus mobility through a network of contact persons at each faculty. Detailed information on each call within Erasmus program will be announced on web pages and info panels at each faculty. Information days will be organized. Handbook for outgoing students and staff will be printed and disseminated. Incoming exchange students will also be provided access to information via web page.

Quality of academic mobility activities:

What kind of specific measures are implemented in the institution to ensure highest quality in academic mobility activities?

Details should be provided in particular on: recognition and credit systems, the provision of information on curricula, information and counselling of outgoing students, tutoring and integration of incoming students, provision of student services (in particular accommodation), preparatory and refresher language courses, facilitation and acknowledgement of staff mobility.

Since academic year 2005/2006 all studies offered at UNIOS are carried out in line with Bologna principles. ECTS has been used for all courses, being fully transferable and acknowledged. University Guide is published for every academic year, listing all courses taught at UNIOS. It will also be published in English in order to have the information prepared for foreign students. International Student Guide is available on web site, providing academic and practical information for foreign students. Documents for incoming students (application form, Transcript of Records, info package), and for outgoing students (selection procedure, Learning Agreement) are prepared and ready to be used. UNIOS appointed Erasmus contact persons at faculties who are in charge of incoming and outgoing mobility. There are three Student Centers that provide services for students, regarding food, accommodation and part-time employment. UNIOS will reserve rooms in dormitories for the purpose of accommodation of incoming students. Students within the Students' Conference will be involved in the acceptance of incoming students. Their duties will refer to tutoring, organization of integration activities and social events. Faculties will organize cultural and orientation programs for exchange students. Intensive course in Croatian language will be organized for free by the Department of Croatian Language and Literature. Teaching activity abroad is one of the preconditions for academic career advancement, as set in the decision of Croatian Rectors' Conference. International Relations Office staff already provides support to outgoing students and teachers. This refers to giving information on available funds and scholarships for mobility, help with travel arrangements and other practical issues. IRO staff will coordinate both student and teacher mobility within Erasmus program and disseminate information through web site, the network of contact persons and through organization of information days.
