Pursuant to Article 43 of the Statute of Josip Juraj Strossmayer University of Osijek and based on the proposal of the Committee for Erasmus+ mobility program, the Rector of Josip Juraj Strossmayer University of Osijek, Prof. Dr. Vlado Guberac makes the following

DECISION

on granting financial support from the Erasmus+ program to incoming (non)teaching staff for training and teaching within individual visit to Josip Juraj Strossmayer University of Osijek

Article I

Allocation of financial support from the Erasmus+ program – Project No. 2020-1-HR01-KA107-077403, is approved to the following (non)teaching staff members:

1. **Raji-Oyelade, Aderemi**, employee of the University of Ibadan, Nigeria
2. **Nantanga, Komeine**, employee of the University of Namibia, Namibia

Article II

Applicants listed in the Article I of this Decision, shall be granted financial support in Euros according to the rules and regulations of the Erasmus+ project 2020-1-HR01-KA107-077403. The mobility for the purpose of training shall be realized at the Faculty of Agrobiotechnical Sciences (Komeine Nantanga) and for the purpose of teaching at the Faculty of Humanities and Social Sciences (Aderemi Raji-Oyelade) of the Josip Juraj Strossmayer University of Osijek, according to the approved Mobility Agreement for Teaching and Training. Financial support will be granted in the amount of 1.960,00 EUR for Komeine Nantanga for a total planned mobility in duration of 14 days (per diems) and 1.960,00 EUR for Aderemi Raji-Oyelade for a total planned mobility in duration of 14 days (per diems), and additional travel costs in the amount of 820,00 EUR for each applicant. Financial support shall be paid out in Croatian Kuna.

Article III

The applicants listed in the Article I of this Decision shall use financial support for the purpose of teaching and training at the Faculty of Agrobiotechnical Sciences (Komeine Nantanga) and Faculty of Humanities and Social Sciences (Aderemi Raji-Oyelade) of the Josip Juraj Strossmayer University of Osijek and for payment of all living costs while staying in Osijek.

Article IV

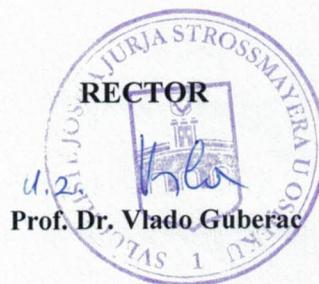
The mutual rights and obligations, as well as final amount of the financial support, which the applicants are entitled to receive, shall be defined in a separate Erasmus+ agreement that will be closed between Josip Juraj Strossmayer University of Osijek and the applicants, as listed in the Article 1 of this Decision.

Article V

This Decision shall enter into force as of the date of signing.

Article VI

Applicants listed in Article I may file a written complaint against this Decision within 8 working days since receiving this Decision.
