# DECISION

on granting financial support from the Erasmus+ program to outgoing teaching staff for teaching within individual visit to the University of Sarajevo, BIH

# Article I

Allocation of financial support from the Erasmus+ program - Project No. 2022-1-HR01-KA171-HED-000076074, is approved to the following teaching staff member:

1. KRASNITSKI, Konstantin, employee of the Academy of Arts and Culture Osijek

## **Article II**

Applicant listed in the Article I of this Decision, shall be granted financial support in Euros according to the rules and regulations of the Erasmus+ project 2022-1-HR01-KA171-HED-000076074. The mobility for the purpose of teaching shall be realized at the Academy of Music of the University of Sarajevo, BIH, according to the approved Mobility Agreement for Teaching. Financial support will be granted in the amount of 1.260,00 EUR for the applicant for a total planned mobility in duration of 7 days (per diems), and additional travel costs in the amount of 180,00 EUR.

## Article III

The applicant listed in the Article I of this Decision shall use financial support solely for the purpose of teaching as an exchange professor at the University of Sarajevo, BIH, and for payment of all living costs while staying abroad.

#### Article IV

The mutual rights and obligations, as well as final amount of the financial support, which the applicant is entitled to receive, shall be defined in a separate Erasmus+ agreement that will be closed between Josip Juraj Strossmayer University of Osijek and the applicant, as listed in the Article 1 of this Decision.

## Article V

This Decision shall enter into force as of the date of signing.

## Article VI

Applicant listed in Article I may file a written complaint against this Decision within 8 working days since receiving this Decision.
