Pursuant to Article 43 of the Statute of Josip Juraj Strossmayer University of Osijek and based on the selection list (proposal) of the Committee for Erasmus+ mobility program, the Rector of Josip Juraj Strossmayer University of Osijek, Prof. Dr. Vlado Guberac makes the following

DECISION

on granting financial support from the Erasmus+ program to outgoing (non)teaching staff for teaching or professional training within the individual visit to Erasmus+ partner university abroad

Article I

Allocation of financial support from the Erasmus+ program – Project No. 2017-1-HR01-KA107-035107, is approved to the following (non)teaching staff member:

1. **KALEM, Hrvoje**, employee of the Catholic Faculty of Theology in Đakovo

Article II

The applicant, as listed in the Article I of this Decision, shall be granted financial support in Euros according to the rules and regulations of the Erasmus+ project 2017-1-HR01-KA107-035107. The mobility for the purpose of teaching shall be realized at the University of Sarajevo, according to the individually approved Mobility Agreement for Teaching. Financial support will be granted in the amount of 160,00 EUR per each day of mobility up to 14 days and 112,00 EUR from 15th day, and additional travel costs in the amount of 180,00 EUR. Financial support shall be paid out in Croatian Kuna.



Article III

The applicant listed in the Article I of this Decision shall use financial support for the purpose of teaching at the University of Sarajevo and for payment of all living costs while staying abroad.

Article IV

The mutual rights and obligations, as well as final amount of the financial support, which applicant is entitled to receive, shall be defined in a separate Erasmus+ agreement that will be closed between Josip Juraj Strossmayer University of Osijek and applicant, as listed in the Article 1 of this Decision.

Article V

This Decision shall enter into force as of the date of signing.

Article VI

The applicant listed in the Article I may file a written complaint against this Decision within 8 working days since receiving this Decision.
