## DECISION

**on granting financial support from the Erasmus+ program to incoming students for the individual study stay at Josip Juraj Strossmayer University of Osijek in the summer semester of the academic year 2017/2018**

### Article I

Allocation of financial support from the Erasmus+ program – Project No. 2017-1-HR01-KA107-035107, is approved to the following students:

### Article II

Applicants – students, listed in the Article I of this Decision, shall be granted financial support in Euros according to the rules and regulations of the Erasmus+ project 2017-1-HR01-KA107-035107. The mobility shall be realized at the Faculty of Food Technology (Amila Voljevica) and Faculty of Social Sciences and Humanities (Toni Ćorić) of Josip Juraj Strossmayer University of Osijek, in the summer semester of the academic year 2017/2018. Financial support will be granted in the monthly amount of 800,00 EUR for study, and additional travel costs in the amount of 180,00 EUR. Financial support shall be paid out in Croatian Kuna.





### **Article III**

The applicants listed in the Article I of this Decision shall use financial support for the purpose of studying at the Faculty of Food Technology and Faculty of Social Sciences and Humanities of Josip Juraj Strossmayer University of Osijek and for payment of all living costs while staying in Osijek.

### **Article IV**




### **Article V**
