



CALL FOR APPLICATIONS FOR UKRAINIAN CITIZENS ENROLLED AT UKRAINIAN UNIVERSITIES APPLYING FOR ERASMUS+ MOBILITY AT JOSIP JURAJ STROSSMAYER UNIVERSITY OF OSIJEK DURING ACADEMIC YEAR 2021/2022 AND ACADEMIC YEAR 2022/2023 WITHIN PROJECT 2021-1-HR01-KA131-HED-000004299

All Ukrainian citizens enrolled at Ukrainian universities (currently residing in Croatia and those who plan to come to Croatia) can apply for realisation of Erasmus+ mobility for the purpose of studies or traineeships at Josip Juraj Strossmayer University of Osijek. Mobility can last a minimum of 2 months and a maximum of 12 months. Students cannot realise their mobility for studies during summer (July and August). Students can realise their mobility for traineeships during summer, but only in private institutions. All applicants who plan to realise their mobility during summer, must organise their mobility, complete the application procedure and submit all required documentation before this call for application closes.

RULES AND CRITERIA FOR APPLICANTS

Applicants must have Ukrainian citizenship. Applicants had to have a student status (be enrolled at Ukrainian university) at the time of leaving Ukraine or be recent graduates from Ukrainian universities who gained their diploma within the period of maximum of 12 months before the date of leaving Ukraine. Recent graduates can realise their mobility only for traineeships, not for studies.

TYPES OF MOBILITIES FOR STUDENTS

Mobility for the purpose of studies - for winter semester 2022/2023

Mobility for the purpose of traineeships – at the University or some other institution in Osijek during academic year 2021/2022 or 2022/2023

APPLICATION PROCESS AND REQUIRED DOCUMENTATION

All applicants must enclose the following official documents in English language:

1. Written application¹ (signed, dated and scanned)

2. Official confirmation of enrolment at Ukrainian university for current academic year (scanned in pdf format)

3. Official transcript of records for current study level at Ukrainian university (scanned in pdf format)

4. Official confirmation issued by applicant's university stating that applicant has a student status (or recent graduate status) and is applying for Erasmus+ mobility at Josip Juraj Strossmayer University of Osijek (scanned in pdf format)

Written application and documents must be sent to the following e-mail: <u>erasmus@unios.hr</u>

University of Osijek will notify applicants on further steps and procedures within 7 working days from the date of receiving the application.

FINANCIAL SUPPORT

Students who apply and meet all requirements gain the right to 1,050.00 EUR for 1 month (30 days) of mobility.

DEADLINES

This call for applications is open from 10/05/2022 to 30/06/2022.

¹Written application should include applicant's personal information – name, last name, address, e-mail, telephone number, home university, current study level and study year and type of mobility the applicant is applying for. It should be written in a form of motivational letter and be approximately one standard page in length (1700 characters).
