Pursuant to Article 43 of the Statute of Josip Juraj Strossmayer University of Osijek and based on the proposal (selection list) of the Committee for Erasmus+ mobility program, the Rector of Josip Juraj Strossmayer University of Osijek, Prof. Dr. Željko Turkalj makes the following

## DECISION

**on granting financial support from the Erasmus+ program to incoming (non)teaching staff for the professional training within individual visit to Josip Juraj Strossmayer University of Osijek**

### Article I

Allocation of financial support from the Erasmus+ program – Project No. 2015-2-HR01-KA107-021518, is approved to the following (non)teaching staff members:

1. **MNATSAKANYAN, Naira**, employee of the Yerevan State University, from Yerevan, Armenia

### Article II

The applicant, as listed in the Article I of this Decision, shall be granted financial support in Euros according to the rules and regulations of the Erasmus+ project 2015-2-HR01-KA107-021518. The mobility for the purpose of professional training shall be realized at the Faculty of Agriculture of Josip Juraj Strossmayer University of Osijek, according to the approved Mobility Agreement for Training. Financial support will be granted in the amount of 100,00 EUR per each day of mobility, and additional travel costs in the amount of 360,00 EUR. The amount approved for per diems can be changed according to calculated amount approved in the Mobility Tool+ system administered by the European Commission. Financial support shall be paid out in Croatian Kuna.



### Article III

The applicant listed in the Article I of this Decision shall use financial support for the purpose of professional training at the Faculty of Agriculture of Josip Juraj Strossmayer University of Osijek and for payment of all living costs while staying in Osijek.

### Article IV

The mutual rights and obligations, as well as the final amount of financial support, which the applicant is entitled to receive, shall be defined in a separate Erasmus+ agreement that will be closed between Josip Juraj Strossmayer University of Osijek and the applicant listed in the Article 1 of this Decision. The Erasmus+ agreement will be closed on site upon applicant's arrival to Osijek.

### Article V

This Decision shall enter into force as of the date of signing.

### Article VI

The Applicant listed in the Article I may file a written complaint against this Decision within 8 working days since receiving this Decision.
