DECISION

Article IV

The mutual rights and obligations, as well as final amount of the financial support, which each Applicant is entitled to receive, shall be defined in a separate Erasmus+ agreement that will be signed between Josip Juraj Strossmayer University of Osijek, the home Faculty of Agrobiotechnical Sciences Osijek and each Applicant personally, as listed in the Article 1 of this Decision.

Article V

This Decision shall enter into force as of the date of signing.

Article VI

Applicants listed in Article I may file a written complaint against this Decision within 8 working days since receiving this Decision.

Article VII

This Decision is issued in English language only to facilitate the administrative procedures required within the Erasmus+ project management.
