Pursuant to Article 43 of the Statute of Josip Juraj Strossmayer University of Osijek and based on the proposal of the Committee for Erasmus+ mobility program, the Rector of Josip Juraj Strossmayer University of Osijek, Prof. Dr. Vlado Guberac makes the following

DECISION

on granting financial support from the Erasmus+ program to incoming students for the individual study stay at Josip Juraj Strossmayer University of Osijek in the summer semester of the academic year 2024/2025

Article I

Allocation of financial support from the Erasmus+ program – Project No. 2024-1-HR01-KA171-HED-000212154 is approved to the following students of the partner institution Tanta University from Egypt (in alphabetical order):

Article II

Applicants – students, listed in the Article I of this Decision, shall be granted financial support in Euros according to the rules and regulations of the Erasmus+ project 2024-1-HR01-KA171-HED-000212154. The student mobilities shall be realized during summer semester of the academic year 2024/2025 at Josip Juraj Strossmayer University of Osijek's Faculty of Civil Engineering and Architecture Osijek.

Article III

The applicants listed in the Article I of this Decision will receive financial support from Josip Juraj Strossmayer University of Osijek in the amount of 800,00 EUR per each month of mobility and travel cost support in the amount of 309,00 EUR. Applicants are obliged to use financial support for the purpose of studying at Josip Juraj Strossmayer University of Osijek and for payment of all living costs while staying in Osijek, Croatia.

Article IV

The mutual rights and obligations, as well as final amount of the financial support, which each applicant is entitled to receive, shall be defined in a separate Erasmus+ agreement that will be closed between Josip Juraj Strossmayer University of Osijek and each individual applicant, as listed in the Article 1 of this Decision.

Article V

This Decision shall enter into force as of the date of signing.

Article VI

Applicants listed in Article I may file a written complaint against this Decision within 8 working days since receiving this Decision.
