The Fulbright Program is the flagship international educational exchange program sponsored by the U.S. government and designed to increase mutual understanding between the people of the United States and the people of other countries. The Fulbright Program was established in 1946 under legislation introduced by former Senator J. William Fulbright of Arkansas. The Fulbright Program in Croatia is a joint program of the U.S. Department of State and the Government of Croatia.

The Fulbright Visiting Scholar Program brings Croatian scholars to conduct nondegree postdoctoral research and/or lecture from 4 up to 9 months at U.S. colleges and universities.

Eligibility Requirements:

- Applicants must be citizens of the Republic of Croatia. Permanent U.S. residents and persons with dual (Croatian and U.S.) citizenship are ineligible
- Applicants must be proficient in oral and written English
- Applicants must hold a Ph.D. in their academic field of study
- Applicants must obtain a letter of invitation from a U.S. host institution
- Applicants must be eligible for a J-1 visa, which requires the grantee to return to Croatia for a minimum of two years at the end of the grant period
- Applicants must receive a satisfactory medical clearance
- Applicants must be employed in Croatia

The Fulbright Foreign Student Program enables young professionals from Croatia who are already enrolled in a PhD program at a Croatian university to conduct 9 month long non-degree research related to their PhD thesis at a U.S. university.

Eligibility Requirements:

- Applicants must be citizens of the Republic of Croatia. Permanent U.S. residents and persons with dual (Croatian and U.S.) citizenship are ineligible
- Applicants must be proficient in oral and written English
- Applicants must be enrolled in a doctoral program (PhD) in Croatia
- Applicants must be eligible for a J-1 visa, which requires the grantee to return to Croatia for a minimum of two years at the end of the grant period
- Applicants already studying in the United States are ineligible for a Fulbright grant
- Applicants must receive a satisfactory medical clearance

The Hubert H. Humphrey Fellowship Program brings outstanding mid-career professionals from Croatia and other countries to the United States for one year. Fellows participate in non-degree academic study and gain professional experience.
