Pursuant to the Statute of Josip Juraj Strossmayer University of Osijek and based on the proposal of the Committee for Erasmus+ mobility program, the Rector of Josip Juraj Strossmayer University of Osijek, Prof. Dr. Vlado Guberac makes the following

DECISION

on granting financial support from the Erasmus+ program to incoming (non)teaching staff for teaching or training within individual visit to Josip Juraj Strossmayer University of Osijek

Article I

Allocation of financial support from the Erasmus+ program – Project No. 2024-1-HR01-KA171-HED-000212154 is approved to the following (non)teaching staff member:

1. **Prof. Dr. Nihada Delibegović Džanić**, employee of the University of Tuzla, BIH

Article II

The applicant, as listed in the Article I of this Decision, shall be granted financial support in Euros according to the rules and regulations of the Erasmus+ project 2024-1-HR01-KA171-HED-000212154. The mobility shall be realized at the Faculty of Education in Osijek, Croatia, according to the approved individual Mobility Agreement. Financial support will be granted to the Applicant in the maximum amount of 1,247.00 EUR in total (of which 1.036,00 EUR will be granted for 7 per diems, and additional travel cost will be granted in the amount of 211,00 EUR).

Article III

The applicant listed in the Article I of this Decision shall use financial support for the purpose of travel, costs of travel and health insurance, and individual stay in Osijek, Croatia, for visiting the Faculty of Education in Osijek, as well as for payment of all living costs while realizing approved mobility.

Article IV

The mutual rights and obligations, as well as the final amount of financial support to which the applicant is entitled to receive, shall be defined in a separate Erasmus+ grant agreement that will be closed between Josip Juraj Strossmayer University of Osijek and the Applicant.

Article V

This Decision shall enter into force as of the date of signing.

Article VI

The applicant listed in Article I may file a written complaint against this Decision within 8 working days since receiving this Decision.
