DECISION

The Applicants shall use the awarded financial support solely for the purpose of professional training at the host Faculty of Economics and Business Osijek and for payment of all travel and living costs while staying in Osijek, Croatia.

Article IV

The mutual rights and obligations, as well as the exact amount of the financial support, which each Applicant is entitled to receive, shall be defined in a separate Erasmus+ agreement that will be signed between Josip Juraj Strossmayer University of Osijek and each Applicant listed in the Article 1 of this Decision.
